 - 4. The SPREE Provide a summary of how each school is performing and improving on the Goals & Guardrails and other important measures in the following areas: Reading and Language Arts, Math & Science, College and Career Readiness, Climate, Culture And Opportunity.
 - 5. Based on that information, each measure gets a color label (blue, green, yellow or red)
 - 6. The SPREE provides each school an overall level -- the combined result of its performance and improvement on each target or measure.
